It is established that 38 voting rights holders are present, and that the EOGA therefore has a quorum. (Attendance list is attached to the minutes )

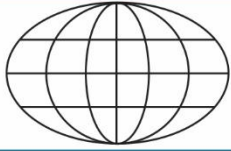
General Secretary Peter Mall explains the voting procedure and asks IT Specialist Jelle Koopman from Swiss Snowsport to explain the technical handling of online voting.
