Topic: Interski Presidium Meeting – Teams call

Date: 29/01/26 – 5 pm

1. The meeting began with the approval of the December 4, 2025, meeting minutes.
2. Discussion then focused on a new social media policy guideline proposed by Vanessa Mann. The policy aims to ensure neutrality by restricting content sharing from non-member or conflicting organizations while promoting member and partner content. The Presidium approved the guideline for internal use. Peter Mall will send out the guideline to the members.
3. There was debate regarding a proposal from Interski Germany requesting a second representative from each pillar at virtual Presidium meetings. Most participants agreed that while transparency is important and minutes should be shared widely, increasing the number of representatives is not necessary at this time. The presidium agreed, that the minutes of our monthly meeting will be shared with the members after being proved by the presidium. Peter will inform Interski Germany of the decision.
4. Updates were provided on several topics:
 - Positive feedback and planned content rollout from team training in Vail, including promotional material (“Road to Vail”), content submission guidelines, and future workshop and lecture proposals.
 - The upcoming in-person meeting is tentatively scheduled for late June/early July to align with fiscal year requirements, with final date decisions to be made by February. Jeff will send us some suggestions.
